## Nursing Workforce

**HB 3369 Updates:** The Oregon Center for Nursing is actively awaiting contract execution for the release of funds from the Oregon Health Authority (OHA) to move forward with its Retaining and Elevating the Nurse Education Workforce (RENEW) Project, supported by monies allocated by HB3396 in the 2023 legislative session. We look forward to sharing updates as information unfolds.
