#### Nursing Workforce

**Staffing Law Research & Impacts:** David Tucker, a PhD student and nurse from the University of Wisconsin, is conducting a study on Oregon's new hospital staffing law. He's <u>seeking</u> <u>perspectives from bedside nurses and managers</u> across both urban and rural settings. The law's implementation, particularly civil penalties, is drawing focus. A <u>webinar by the Oregon Health</u> <u>Authority</u> is scheduled for July 16 to explain what those penalties mean operationally for hospitals. Concerns were raised about rural hospitals managing the staffing law, especially under tighter resources and workforce strain.

**Behavioral Health Integration:** The <u>Cambia Foundation announced a grant opportunity</u> for integrating behavioral health workforce into primary care. It's open to organizations in OR, WA, ID, and UT. Nursing-led proposals are encouraged.

**Medicaid Cuts & Moral Distress:** Federal Medicaid changes passed last week are causing concern, particularly for the implications on nurse employment in systems dependent on Medicaid funding and patient care access and outcomes. OCN discussed providing resources to better understand the timeline and impact, including fact sheets, blogs, and webinars; <u>contact Jana Bitton</u> if you are interested in helping create these resources.
