NURSE WORKFORCE

Medicaid Budget Pressure: Huddlers discussed a looming state budget gap, anticipated painful cuts, and concern that federal changes could hit Oregon disproportionately, alongside specific concern about CCO rate-setting and CCOs pulling out of local markets.

Patient Safety & ICE Concerns: A bill is in development related to ICE and hospitals, intended to address concerns being raised about how ICE behaves and access to healthcare facilities. OCN's Legislative Tracker will be released soon to track all nursing related bills.

Staffing Law Reality Check: A statistic from the Oregon Health Forum was cited that implementing staffing ratios cost \$400M to hire needed nurses plus \$200M to administer; participants questioned the figure and shared that staffing challenges and complaints persist even after the staffing law, with "break nurse" roles often pulled first when units are short.

Vaccine Recommendations and Standing Orders: OSBN and partners are actively discussing vaccine standing order approaches, alongside questions raised about guidance alignment for FQHCs—particularly for organizations near state borders navigating federal vs. West Coast Health Alliance recommendations.
